I acknowledge and agree that:

- 1. In this Entry Application and Declaration: "Organising Authority" means and includes jointly and severally: Sorrento Sailing Couta Boat Club Inc of Foreshore Sorrento, its directors, officers, members, servants or agents. "Claim" means and includes any action, proceeding, claim, demand, damage or expense however arising including but not limited to negligence but does not include a claim in respect of any action, suit etc made by any person entitled to compensation under a relevant Club insurance policy or under any right expressly conferred by the constitution of the Organising Authority. "Regatta" means and includes all events and activities both on and off the water in connection with a sailing coaching and or a learn to sail program conducted for or on behalf of the Organising authority.
- 2. If accepted I will be permitted to participate in the Regatta/Training subject to my complying with the terms and conditions of the Regatta/Training this declaration and any reasonable direction issued by the Regatta/Training organisers or their representatives.
- 3. The Regatta/Training rules and this declaration comprise a contract between me and the Organising Authority and are necessary and reasonable to promote and conduct the Regatta/Training. I agree to abide and be bound by the ISAF Racing Rules of Sailing, rules and policies of Yachting Australia (copies of which are available from Yachting Australia) and all other Rules that govern the Regatta/Training, and be subject to the jurisdiction of Yachting Australia and the Organising Authority in relation to the application and enforcement of such rules and policies.
- 4. Warning: Participation in the Regatta/Training can be inherently dangerous. I acknowledge that I am exposed to certain risks during my participation in the Regatta/Training including, but not limited to, physical exertion and injury, bodily contact, falls, equipment failure and unpredictable weather conditions. I acknowledge that accidents can and often do happen which may result in me being injured or even killed, or my property being damaged. I have voluntarily read and understood this warning and accept and assume the inherent risks in participating in the Regatta/Training.
- 5 For the purposes of this clause 5, "the Supplier" shall mean and include the Organising Authority.

Exclusion of Implied Terms: I acknowledge that where I am a consumer of recreational services, as defined by any relevant law, certain terms and rights usually implied into a contract for the supply of goods or services may be excluded. I acknowledge that these implied terms and rights and any liability of the Supplier flowing from them, are expressly excluded to the extent possible by law, by this Entry Application Declaration. To the extent of any liability arising, the liability of the Supplier will, at its discretion by limited to the resupply of the services or payment of the cost of having the services supplied again.

- 6. Release and Indemnity: In consideration of the Organising Authority accepting my application for entry to the Regatta/Training I, to the full extent permitted by law:
- (a) release and will release the Organising Authority form all Claims that I may have or may have had but for this release arising from or in connection with my participation in the Regatta/Training; and
- (b) indemnify and will keep indemnified the Organising Authority in respect of any Claim by any person including but not only another participant in the Regatta/Training arising as a result of or in connection with my participation in the Regatta/Training.
- 7. Fitness to Participate: I declare that I am and must continue to be medically and physically fit and able to participate in the Event. I will immediately notify the Organising Authority in writing of any change to my fitness and ability to participate. I understand and accept that the Organising Authority will continue to rely upon this Declaration as evidence of my fitness and ability to participate.
- 8. Consent to medical treatment: If required, the Organising Authority will arrange medical or hospital treatment (including ambulance transportation) for me. I authorise such actions being taken by the Organising Authority where my further consent cannot be obtained and agree to meet all costs associated with such action.
- 9. Privacy: I understand that the information I have provided is necessary for the conduct of the Regatta/Training. I acknowledge and agree that the information will only be used by the Organising Authority to facilitate the conduct of the Regatta/Training. I understand that I will be able to access my information through the Organising Authority. If the information is not provided my entry application may be rejected.
- Severance: If any provision of this declaration is invalid or unenforceable in any jurisdiction, the phrase or clause is to be read down for the purpose of that jurisdiction, if possible, so as to be valid and enforceable. If the phase or clause cannot be so read down it will be severed to the extent of the invalidity or unenforceability. Such severance does not affect the remaining provisions of this Entry Application declaration or affect the validity or enforceability of it in any other jurisdiction.
 I have read, understood, acknowledge and agree to the above declaration including the warning, exclusion of implied terms, release and indemnity. I warrant that all information provided in my Entry Application is true and correct. I acknowledge that this Entry Application Declaration cannot be amended. If I do amend it my application will be null and void.
