### 1. RULES

- 1.1. The regatta will be governed by the rules as defined in the Racing Rules of Sailing (RRS) including AS Special Regulations Part 1 Cat 7
- 1.2. Appendix S – Standard Sailing Instructions and Appendix T - Arbitration shall apply

### 2. ELIGIBILITY AND ENTRY

- 2.1. The regatta is open to Jubilees of members of an Australian Jubilee Yacht Association.
- 2.2. All boats shall be entered and skippered by a current financial member of a District of the ILCA
