## NOTICE OF RACE

#### 1. RULES

- 1.1. The regatta will be governed by the rules as defined in the Racing Rules of Sailing (RRS) including AS Special Regulations Part 2 Off the Beach boats
- 1.2. Rule 26 will be changed to a 3 minute sequence.
- 1.3. Appendix S – Standard Sailing Instructions and Appendix T - Arbitration shall apply

#### 2. ELIGIBILITY AND ENTRY

- 2.1. The regatta is open to all boats of the Laser Standard, Laser Radial and Laser 4.7 Classes
- 2.2. All boats shall be entered and skippered by a current financial member of a District of the ILCA

- 3.1. \$60 per boat Early Bird entry or \$70 per boat if entered after Monday 25th September 2017
