### 1. RULES

- 1.1. The regatta will be governed by the rules as defined in the Racing Rules of Sailing and Australian Sailing Special Regulations Part 2 Off the Beach Boats.
- 1.2. Appendix S: Standard Sailing Instruction and Appendix T; Arbitration will apply
- 1.3. Changes to rules that will be detailed in full in the sailing instructions include:
  - Outside help to recover a crew overboard or separated and return them to their boat with no advantage will be allowed.

### 2. ELIGIBILITY AND ENTRY

- 2.1. Boats may be entered by members of their class Association by agreeing to the [conditions of entry](#), paying the entry fee and completing the entry form, which contains other conditions and an alert about the risks of sailing which the person entering the boat, must agree to [ENTER HERE](#)

### 3. FEES

- 3.1. The entry fee is \$100 per boat entered by Friday 22/3/2019
- 3.2. An additional \$50 late entry fee will apply to each boat entered after Friday 22/3/2019
- 3.3. Entry closes at 5 pm Friday 29/3/2019

### 4. SCHEDULE and FORMAT

- 4.1. Racing will be conducted in sessions, 3-4 shorter races per day are planned depending upon weather conditions and forecast.
- 4.2. Presentations will be held each day after racing.

- 5.1. The sailing instructions will consist of the instructions in RRS Appendix S, Standard Sailing Instructions, and supplementary sailing instructions that will be on the official notice board located at Regatta Office.

- 6.1. Boats shall hold a valid measurement certificate and sails shall have been measured.
- 6.2. Boats may be inspected for compliance with Safety Regulations and Class Rules at any time.

## 9.1. **Symmetrical Spinnaker Challenge**

Boats will be scored using YV Handicaps.

Class Team scores will be the combined series scores equal to the number of boats in the smallest class less one.

- 9.2. Each class will also be scored as a separate class and series excluding a boat's worst score once 4 races are completed.
- 9.3. 3 races must be completed to constitute a series.

## 10. **SUPPORTERS**

- 10.1. Supporters who are not SSCBC members will be granted honorary membership on regatta days and are required to abide by the Rules and Codes of SSCBC and Australian Sailing and comply with any reasonable request from the Race Committee, including maintaining separation from boats racing and supporting rescues of other boats where required if afloat.

## 11. **PRIZES**

- 11.1. Class Prizes will be awarded by the Associations
