What are we aiming to achieve?

- Provide pathways for Membership
- Equitable fees for new and existing members
- Encourage growth of some categories
- Financially sustainable
- Smooth transition
- More manageable



- Change name from "Ordinary Members" to simply "Members"
- Continue to encourage Couples and Families to join with fee incentives however through a more a equitable and progressive approach
- Provide a concessional rate to Members aged 75 years and over with 20 years of membership
- Discontinue Country, Interstate and Overseas membership categories
- Expand the use of the Absentee Membership category
- Discontinue Student membership categories however, provide a concession rate to Young Adults studying full time
- Discontinue Restricted Sailing membership category
- Discontinue Associate membership category



The resulting membership categories will be simply:

MEMBERS YOUNG ADULT MEMBERS ABSENTEE MEMBERS JUNIOR MEMBERS HONORARY, HONORARY LIFE AND PAID LIFE MEMBERS

Within these categories fees will structured

Transition arrangements will provide smooth transition where appropriate



The proposal states that Join fees are only payable by new members and that all join fees paid prior to 30/6/21 will be recognised

The impact of this is that there will be no additional joining fee payable for existing Junior, Student and Young adult members provided they do not resign. It is assumed that a join fee was paid or not required to be paid at their time of joining and their status as "Join fee paid" will be preserved by virtue of their member since date being prior to 30 June 2021.



Whilst the family invoice rate in its current form is being discontinued, family membership options remain, with increased relevance

SSCBC is a progressive and inclusive club and recognises that families do not always comprise of two parents and two or more children aged under 18. The Family subscription rate in its current form does not give consideration to single child families, or single parent families or for children aged 18 or over which are prima facie part of a family unit.

It is recognised that 18 year olds often remain part of a family unit both in terms of living, dependency and therefore, membership subscriptions.

The proposed structure, allows families of many shapes and sizes to establish their bespoke family unit.



A couple will comprise of two Members, albeit one of those Members will be entitled to a "Subsequent" rate

There is no proposal to deem one of the Members within a couple or family as a Subsequent.

Both are *Members* in name and substance

They will be entitled to the "subsequent rate" provided they are in a bone fide couple (living at same abode).

This construct is common at sailing and other member clubs

Young adults studying full time will be entitled to a concessional rate of 50%. This will be granted to all Young Adult members who provide evidence of their full time student status as at the first day of the subscription year. Note that the current Student category required "dependency" and under 25. It is not practical to monitor dependency and student status may extend beyond 25.

The Committee believe that the Young Adult category (with full time student concession available) will be highly attractive to new members in this category by virtue of the attractive rate and deferral of any join fee requirement until 30 years.

We note that Junior Members and Young Adult Members have been entitled to apply for membership without parents. There is no amendment proposed to this practice

The Committee recognise that for personal or professional reasons, Members may wish to defer their Membership rights and elect to be Absentee members.

Absentee membership will preserve Member status and Joining fee status.

It is recognised that Absentee members may wish to visit their club. As such, it is proposed that Absentee members may request temporary membership rights for a weekend or similar by application to the CEO or Membership Manager.

Historically, Absentee membership has not been equitably ascribed to family groups. The proposed structure will address this anomaly.

Absentee rates are based on 20% of the prevailing rate for each respective Membership subscription category



Illustrative impact on subscriptions – Country/Interstate/Overseas

Based on the Committee's assessment of Membership trends, Country, Interstate and Overseas members predominantly fall into two categories:

- 1. Those who maintain residences on the Mornington Peninsula (Peninsula) where they spend a material portion of the year; and
- 2. Those who have moved their permanent abode and spend little or no time on the Peninsula each year.

In the case of category 1, the time available to enjoy club access and amenity is comparable or greater to many Members who pay a full subscription. This is particularly the case for families with parents who work and children who attend school. These groups may spend one to two weeks on the Peninsula from Christmas into early Jan, and then the odd weekend or long weekend.

As such, the grounds for a materially reduced subscription do not exist.

In the case of category 2, we recognise that for work or personal reasons, a Member may relocate and have limited or no opportunity to visit the Club and enjoy its amenity and services. In contemplating this, the proposed rate for an Absentee couple will reduce.

Its is therefore proposed that Country, Interstate and Overseas categories are discontinued and Members in these categories will be invited to elect to be Members or Absentee Members

As previously stated, there will be no additional joining fee payable for existing Junior, Student and Young adult members provided they remain financial.

Join fees will be payable by new members aged 30 years and over

New (admitted post 1 July 2021) Junior and Young Adult Members upon reaching 30 years, will be required to pay their join fee at this time. However their join fee will be reduced by a percentage amount equal to two times their consecutive years of membership – further explained on next slide.

Joining fees may be paid over two years by application to the General Manager

A key objective of SSCBC is to attract and retain Young Adult Members. Consistent feedback has identified that the join fee is a significant deterrent to new members from this demographic.

Further, we currently see past Junior members lose contact and resign membership in their 20s. The discount approach will hopefully create an incentive to remain a financial and an active member.

The table on the left presents the illustrative join fee payable, at the proposed season 21/22 rate.
