2. Annual Reports of the Committee

2.1 Commodore's Report

Commodore Graham Cunningham delivered his Annual Report. Graham steps down after 3 years as Commodore. Thanked family & friends for coming to this meeting

Some of the highlights of his report were:

- Thanking the committee and management team
- Implementation of New membership management system, upgrading accounting and payroll systems, F&B systems and members management system (MMS)
- F&B successes in-house and building this throughout winter. Taking food & beverage services in house. Turned a profit in 2021.
- Greater limitations on repeat guests to allow better access for members
- Sailing training, increasing sailing participation in the Club. Couta Boat training and use of Ripple, increased use of involvement of Next Gen
- Financial sustainability of the club, improved governance & reporting
- Simplification & rationalisation of membership categories
- Size of the Club. Currently have 4,400 members. Largest membership base of a sporting club in Australia

Graham reflected on many memorable moments he has had over the last 3 years as Commodore

- Dining Japanese themed Olympic lunch at club 31 July, dinner for Bastille Day, wine tastings, Men's good health lunch, regular seasonal lunches, summer drinks

- Restoration of wooden Jetty
- Club operations during re-development of Club.
