Member

A Member is a person who is 30 years or older on the first day of the membership year and whose membership has been approved by the Committee.

Member (subsequent rate)

A Member Subsequent rate is available to a married or de facto partner of a Member, and who permanently resides at the same address as the Member and whose membership has been approved by the Committee.

Young Adult

A Young Adult Member is a person aged between 18 and 29 years on the first day of the membership year and whose membership has been approved by the Committee.

Young Adult (concession rate)

To qualify for the concession rate, students must provide satisfactory evidence of full time student status each year and whose membership has been approved by the Committee.

Junior

A Junior Member is aged up to 17 years on the first day of the membership year and whose membership has been approved by the Committee.

For those applicants who, either for geographic or personal reasons, are unable to use Club facilities and services, may elect to be Absentee Members.
